The minutes were passed by the committee.

3. MATTERS ARISING

a) Court cases- The following are outstanding bills for barristers for defending the following devotees

£150.00 for Suredra Patel £275.00 for Paresh Patel

The barristers were hired by Jitesh who was trying to protect the interests of the devotees and if he didn't hired barristers the above mentioned devotees would probably get higher fines. HKTDM approved paying of these expenses.

However, in the discussion was mentioned that most of the cases that go to magistrates court are 'police obstruction' cases. This is to be looked into further especially with the regards to our complaints against the behaviour of the police officers on the 26th May 1994.

There was a plan of action set for getting our case before the Police Complaints Authority ie to contact three independent, professional individuals (Sh. Jitesh Thakrar, Cllr Kanta Patel and Cllr. Chunni Chavda) who would then go through all our evidence and give us their opinion whether we should proceed further with our case.

Above mentioned individuals were contacted by Sh Riddha das and did not seem to be interested in getting involved. They are now to be contacted again by Sh Naresh Chadha in order to try to encourage them in helping us. I n case they still express hesitation of further involvement there is an additional list of people to be contacted: Sh.Shantoo Ruparel, Cllr.Lata Patel and Sh.Ravindra Pathak.

Naresh Chadha to report to HKTDM on the progress of situation.

b) From the meeting held on the 24th October - Diwali - Sh. Akhandadhi das did write to the Council about our proposal of having the restricted Diwali (no advertising, no outdoor activities, no tents, no fireworks) and is waiting for their reply. He will meet with Mr Copland on Monday and be informed about Council's decision.

In the case that Council says YES than we will just go forward and have the festival as planned. If the Council says NO to our proposal than we have to be prepared for the Sunday. NO means that the gates will have to be closed on the day and this will cause a lot of problems for which we need an action plan as follows:

- 1. Police will probably try to divert the traffic at the key entrance points to Letchmore Heath (Haberdashers School, Round Bush, Batlers Green, Sandy Lane). At these points we should have our people warning everyone that it is still legal for them to go to the village itself and worship from outside the temple. In this case police will not be able to send people away. Sh Naresh Chadha will co-ordinate this (getting people organised for covering these spots).
- 2. Once people get into the village there should be 'programme' organised for them such as offering the arati, climbing the ladders to enter the temple etc. Note that a lot of attention has to be paid to the security, especially with the ladders. Sh. Nitesh Gor, from Pandava Sena, will organise this.
- 3. As the attendance on Diwali may not be as much as we would like it and people who are coming require to be informed before hand how to deal with the police, there is a need for some networking to be done. This is delegated to Sh. Subash Mehta.

Leaflets are to be printed and distributed at all key points to inform people what to say to the police and also that they know what is happening in general.

- a) South Africa Sh. Akhandadhi das contacted the temple in Durban and was told that Mr. Nelson Mandela is actually not visiting our temple there perse, but the temple is serving as a venue for his meeting with a local Hindu organisation so he could not spend any time with us. However, a letter, form NCHT, is to be given to him describing our case and he is to be approached for a meeting with our delegation when he visits London in December.
- b) Public inquiry regarding the rally on the 15th January 1995 we should book Trafalgar Square now and start getting things prepared.
- c) Eastern Eye they have approached Sh Naresh Chadha for an interview featuring the Manor's situation. He is given full freedom to deal with them.
- d) Anti Racist Alliance they sent a letter to Sh Bimal Krishna expressing the possibility of getting some help from them and Sh Bimal Krishna is to contact them further and report back to the HKTDM.
- e) Criminal for Krishna fund-raising suggestion by Cllr Ward to get the Hindu community to take the prosecution on themselves, because they were the ones who actually broke the law on Janmashtami. The badges could be made with the slogan "Criminal for Krishna" and sold for £1.00 each and if all those who came here for Janmashtami buy one then we would have substantial increase in our campaign funds. This would also cause many people to identify with the temple even more than what they are now. Suggestion welcomed and it is to be explored after Diwali.
